Heurkens Johannes Jacobus Hendricus and Elisabeth Helena Maria (van Grootel) Heurkens Hermanus and Petronella Hendrina (van Haren) Boxtel van Adrianus Petrus and Antonia Anna (Heurkens)

Johannes Jacobus Hendricus (Jan) Heurkens lived with his wife Elisabeth Helena Maria (Bets) van Grootel in Geldrop, in the Dutch province of Noord-Brabant. Both were born in 1907. Jan Heurkens was part of a nationally organized resistance group (LO: 'Landelijke Organisatie') and had contact with local clergymen and resistance members. Jan was Municipal Secretary; thanks to this position he had access to the person registers of the town. He falsified details and identity cards, arranged food coupons for hiders and organized hiding places for shot down pilots.

In their home in Geldrop, Jan and Bets Heurkens hid a Jewish boy. His name was Lodewijk Theodoor Manne (Luuk) Ornstein and he was about twelve years old. Luuk's father was a famous professor of physics (Leonard Salomon Ornstein), who had passed away in 1941. Luuk's mother Sophia Estella Ornstein-Meijer took Luuk and his brother Mathijs Alexander Manne (Thijs) to Eindhoven, Brabant, in the South of Holland. Many of Leonard Ornstein's former students worked there in a physics laboratory. In Eindhoven mother and sons Ornstein went into hiding separately.

Luuk was sheltered by Jan and Bets Heurkens. He was called 'Luuk van der Steen'. After a raid on the distribution office in Geldrop and the town hall in Mierlo in 1944, Jan Heurkens went into hiding. In the meanwhile, an infiltrator in the resistance group betrayed resistance members, among them the persons who performed the raids. 17 Persons were arrested; Jan Heurkens was not between them. After a week, Jan returned home for Bets Heurkens' birthday on May 22th. That moment Nazi policemen arrested him; they had been waiting for his arrival at the other side of the street. The Sicherheitsdienst regarded Jan Heurkens as the leader of the resistance group. In Haerendaal, Jan was interrogated brutally and then transferred to Camp Vught. On August 9th Jan was shot, shortly before the liberation of Noord-Brabant.

In the meantime, Luuk Ornstein remained with Bets Heurkens. The Nazis had no idea that the Heurkens were also hiding a Jewish boy. During his stay with the Heurkens, Luuk Ornstein played with the neighbors' daughter, who was three years younger. Luuk went to school in Eindhoven during his hiding time, under a false identity.

Thijs Ornstein, Luuk Ornstein's younger brother by two years, was hidden by some families in Waalre, while he attended school in Eindhoven. He was called Thijs van den Broek. On his eleventh birthday on February 4th 1944 he was in immediaty danger due to betrayal and he was transferred to farm of Jan Heurkens' parents Hermanus (Herman) and Petronella Hendrina (Nel) Heurkens (van Haren) in Nederasselt. They had 13 children, of whom Jan was the eldest. Petronella Heurkens, Jan's mother, was a strong and special lady, who was sheltering evacuees and hiders, so that they were sometimes with 30 persons at the table. Thijs was presented as a child from Rotterdam whose father had died and whose mother and brother stayed at other addresses.

Towards the end of the war, after the arrest of Jan Heurkens, Thijs was temporarily sheltered by Adrianus Petrus (Adriaan) van Boxtel (b. 1910) and his wife Antonia Anna (Tonny) Heurkens in Lienden (Gelderland). Tonny was Hermanus and Petronella Heurkens' daughter. After Jan Heurken's death, Thijs returned to the Heurkens family in Nederasselt, where he stayed until the liberation in September 1944. With chalk he wrote his real name Thijs Ornstein on one of the tanks. In the evening they feared for a counterattack by the Germans and Thijs was very worried that his name on the tank would give him away. Fortunately, that did not happen.

After the war, Thijs and Luuk Ornstein and their mother reunited and they settled in Amsterdam, first with Sophia's brother and his family. The Ornsteins remained in warm contact with their rescuers and their families.

On 4 October 2021 Yad Vashem recognized Johannes Jacobus Hendricus & Elisabeth Helena Maria Heurkens (van Grootel), Hermanus & Petronella Hendrina Heurkens (van Haren) and Adrianus Petrus & Antonia Anna van Boxtel (Heurkens) as Rigtheous Among the Nations.
